**Contract is between Furkidz, LLC and the pet owner:**

1. Owner understands and agrees to pay daily boarding rate
2. Furkidz is not responsible for lost or damaged pet items
3. Owner agrees to pay for Capstar flea pill (\$10) if the pet has fleas upon arrival
4. Furkidz is not responsible for any pre-existing or breed-related conditions
5. All pets must be healthy. Furkidz is not responsible for any stress induced illnesses (i.e. skin allergies, diarrhea, eye discharge, loss of hair/feathers)
6. In the event of an emergency, I authorize Furkidz LLC to seek medial treatment for my pet. Owner is liable for any and all expenses incurred
7. **No Verbal Modifications.** All modifications to the Contracts must be made in writing. Such modifications which must be made in writing include, without limitation, changes to Owner's contact information, Owner's veterinarian preference, the accommodations Owner prefers for Owner's pet(s), any dietary restrictions for Owner's pet(s), whether Owner permits Owner's pet(s) to socialize with other animals, whether Owner permits pet(s) to engage in "play time," and the feeding instructions for Owner's pet(s). The aforementioned list of items requiring written modifications is not an exhaustive list – all modifications must be in writing.
8. **No Verbal Instructions.** Any instructions related to the care and/or oversight of Owner's pet(s) shall be in writing. If the Contract does not contain the special instructions Owner wishes to specify, or if the Contracts do not call for such information, Owner agrees to provide those instructions in writing.
9. **Release of Liability.** The undersigned Owner hereby agrees to release FurKidz, LLC, its agents, and employees from any and all claims, rights and causes of action of any kind arising out of any injuries, illnesses or otherwise sustained by Owner's pet(s) while receiving services provided by Furkidz, LLC or while kenneled at Furkidz, LLC. Further, the undersigned Owner hereby agrees to release FurKidz, LLC, its agents, and employees from any and all claims, rights and causes of action of any kind arising out of any injuries or illnesses sustained by Owner while on premises at Furkidz, LLC. Owner hereby agrees that Owner shall not challenge the sufficiency of the consideration exchanged for this release of liability.
